

This technical memorandum presents findings of existing conditions and projects for consideration at the Kingston Avenue/Linda Avenue/Rose Avenue intersection in Piedmont, California. Two design concepts were considered:

- **Concept 1** involves a landscaped median that occupies the currently empty median space on Kingston Avenue south of Linda Avenue. Concept 1 does not modify traffic patterns or parking supply.
- **Concept 2** consists of enlarging the landscaped median beyond the empty median space, converting the two-way portion of Kingston Avenue south of Linda Avenue and east of the triangle into a northbound-only facility. Parking supply along Kingston Avenue will not be impacted by Concept 2.


The following sections discuss data collection, traffic analysis, and potential changes to pavement markings and traffic control. Figure 1 and Figure 2 summarize the potential improvements Kittelson & Associates, Inc. (KAI) identified for the City's consideration for Concept 1 and Concept 2, respectively.

## PROJECT BACKGROUND

The City of Piedmont is considering landscaping and traffic engineering changes to the Kingston Avenue/Linda Avenue/Rose Avenue intersection. Figure 3 is an aerial photo of the existing conditions.

## City of Piedmont Pedestrian and Bicycle Plan Recommendations

The City of Piedmont Pedestrian and Bicycle Master Plan<sup>1</sup> outlines several recommended projects around the study intersection. These are noted below.

- An “enhanced bike route” for the entire length of Linda Avenue (from Grand Avenue to City limit). The Pedestrian and Bicycle Master Plan defines an “enhanced bike route” as one which includes sharrows on the pavement as well as “Bikes may use full lane” signs.
- A regular bike route for the entire length of Rose Avenue (i.e., from Linda Avenue to Grand Avenue). A regular bike route is defined in the Master Plan as one without the sharrows but with the roadside signs noted above.
- An enhanced street crossing at Linda Avenue to serve students of the nearby Beach Elementary School.

## Pedestrian and Bicycle Plan Comments

The Pedestrian and Bicycle Master Plan also provides a record of citizen input for projects around the City of Piedmont. KAI reviewed the unedited comments included in the appendices to the Pedestrian and Bicycle Master Plan and found the following general themes to apply to the Kingston Avenue/Linda Avenue/Rose Avenue intersection:

- The intersection is large and confusing
- Vehicle speeds are high, particularly those of vehicles traveling eastbound on Linda Avenue
- Visibility of pedestrians on the intersection's crosswalks can be increased, especially at night
- Stop signs, or even traffic signals, may improve intersection operations

## EXISTING CONDITIONS


To inform the technical analyses and recommendations in this report, KAI collected midweek 48-hour automated traffic volume data on Linda Avenue near the study intersection. In addition to the bidirectional traffic volume data, KAI also collected speed and vehicle classification data. These counts were performed on Tuesday, October 21, 2014 and Wednesday, October 22, 2014.

KAI collected automobile, bicycle, and pedestrian counts for the morning and afternoon peak periods of Wednesday, November 5, 2014. Traffic data summaries are presented in Figure 4 and Figure 5.


As described in the introduction to the *California Manual for Uniform Traffic Control Devices* ("CA MUTCD") Section 2B.07, multi-way control is intended for situations where the volume of traffic on intersecting roads is about equal. To evaluate this criterion, the daily traffic volumes were calculated for the combined major street and minor street approaches to the study intersection.

## HISTORICAL CRASH ANALYSIS

In accordance to Criterion B found in Section 2B.07 of the CA MUTCD, KAI reviewed crash data for the intersection. KAI used data from the California Highway Patrol Statewide Integrated Traffic Records System (SWITRS) for the crash data review. KAI analyzed the crash data at the study intersection from 2009-2013; crash data for 2013 are complete through the month of November.

Table 1 summarizes the crashes recorded at each study intersection during the January 1, 2009-November 30, 2013 study period.

**Table 1. Historical Crash Data Summary January 1, 2009- November 30, 2013**

Improper turning was cited as the primary contributing factor. There were no injuries or fatalities.</li><li>On <b>September 12, 2012</b>, a PDO crash took place at the study intersection. The primary contributing factor was cited as "hazardous parking". There were no injuries or fatalities.</li><li>On <b>October 26, 2012</b>, an automobile-bicycle crash resulting in one injury occurred at the study intersection. A violation of traffic signals or signs by the automobile was cited as the primary contributing factor. The pavement was dry and it was dark with street lights on at the time of the crash.</li></ul>

## MULTIWAY STOP CONTROL WARRANT

### Background

Installing an all-way stop control treatment is typically based on the guidelines set forth in CA MUTCD. As of this writing, the 2014 edition is the latest version of the manual. Section 2B.07 deals specifically with all-way stop control and is reproduced in its entirety in Appendix B.

An all-way stop control sign can serve as an effective and valuable traffic control device; the provisions in the CA MUTCD are used assess locations that may be candidates for all-way stop



control. Unwarranted stop signs have been found to exhibit poor driver compliance, increased crashes and increased speeds.<sup>2</sup>

KAI used the following criteria to evaluate multiway stop sign installation at the study intersection; the criteria were applied in accordance to the 2014 CA MUTCD Section 2B.07 Multiway Stop Applications.

### **Criterion A**

Criterion A is applicable where traffic control signals (i.e., a traffic light) are justified, such that an all-way stop sign would serve as an interim measure. Because the study intersection does not meet traffic signal warrants, **Criterion A is not met**.

### **Criterion B**

All-way stop control could be considered if five or more crashes correctable by all-way stop control are reported within a 12 month period. Such crashes include right-turn and left-turn crashes as well as angle crashes. As described in detail in the Historical Crash Analysis section, the study intersection has had one crash correctable by all-way stop control in the last five years (i.e., the broadside crash in December 21, 2009). Because the number of applicable crashes is below the minimum five crashes per year, **Criterion B is not met**.

### **Criterion C**

Criterion C is based on minimum vehicular and non-motorized traffic volumes at the intersection. As described in the introduction to CA MUTCD Section 2B.07, multiway control is intended for situations where the volume of traffic on intersecting roads is about equal. The CA MUTCD calls for a minimum of 300 vehicles per hour on the major street and 200 vehicles, pedestrians, or bicyclists per hour on the minor street. These minimum volumes must be present for any eight hours of an average day.

Based on the AM and PM peak hour manual data collection and the 48-hour machine counts summarized in Figure 4, the study intersection exceeds 300 vehicles per hour on the major street and 200 vehicles per hour on the minor streets in both peak hours. With the addition of non-vehicular traffic, minor street volumes reach 290 units per hour in the AM peak hour and 239 units per hour in the PM peak hour. Using the 48-hour counts to supplement the manual data collection, KAI concludes that these traffic levels are sustained for the majority of the time between 7 AM and 7 PM.

Based on the observed traffic volumes, **Criterion C is met**.

## **Criterion D**

If no single criterion is met, but both Criteria B and Criteria C are satisfied to 80 percent of the minimum values, all-way stop control should be considered. Based on the findings for Criteria B and Criteria C, **Criterion D is not applicable**.

## **Additional Criteria**

The CA MUTCD allows an engineering study to consider criteria that would justify installing all-way stop control. These criteria take into account:

- A. The need to control left-turn conflicts;
- B. The need to control vehicle/pedestrian conflicts near locations that generate high pedestrian volumes;
- C. Locations where a road user, after stopping, cannot see conflicting traffic and is not able to negotiate the intersection unless conflicting cross traffic is also required to stop; and
- D. An intersection of two residential neighborhood collector (through) streets of similar design and operating characteristics where multi-way stop control would improve traffic operational characteristics of the intersection.

**The four additional criteria established by the CA MUTCD are applicable to the study intersection:**

- Left-turn movements from northbound Kingston Avenue could benefit from traffic control on Linda Avenue as indicated by Criterion C being met.
- The nearby Beach Elementary School is a pedestrian generator with the potential for pedestrians to travel through the Kingston Avenue/Linda Avenue/Rose Avenue intersection.
- With the implementation of the landscaping plan, vehicles traveling northbound on Kingston Avenue may not be able to negotiate the intersection unless Linda Avenue traffic was also required to stop.
- The combination of Rose Avenue and Kingston Avenue carry a similar amount of traffic as Linda Avenue. While vehicular operations may degrade for users of Linda Avenue with a stop sign installed, conflicts between different vehicle movements and different modes are expected to be reduced.

## POTENTIAL CHANGES TO PAVEMENT MARKINGS AND TRAFFIC CONTROL

KAI identified potential changes to pavement markings and traffic controls based on the background information, the traffic data, and the Multiway Stop Control Warrant analysis presented above.

The potential changes consider automobile operations, pedestrian and bicycle safety, and transit access at the study intersection. Figure 1 and Figure 2 at the beginning of this report summarize the potential changes for the City's consideration for **Concept 1** and **Concept 2**, respectively.

### Automobile

#### *Traffic Control*

- Place “STOP” signs (CA MUTCD R1-1) on the eastbound and westbound approaches of Linda Avenue at the intersection with the two-way Kingston Avenue, as shown in Figure 1. Install an “ALL WAY” plaque (CA MUTCD R1-3P) below each stop sign in the intersection.
  - KAI evaluated two other options for traffic control: (1) a five-way stop control with stop signs at each approach to the intersection. From the field review we concluded the intersection is too complex for vehicles on either approach of Linda Avenue, and particularly for eastbound motorists, to identify when it is appropriate for them to enter the intersection; and (2) two four-way stop-controlled intersections in immediate succession. However, two stops on eastbound Linda Avenue would be less than 100 feet apart, which may not be intuitive to drivers and may not meet their expectations.
  - Figure 1 and Figure 2 illustrate a traditional four-way stop intersection under **Concept 1** and **Concept 2**, respectively.
  - The modifications of traffic patterns inherent in **Concept 2** result in additional travel for two movements: (1) southbound through traffic on Kingston Avenue and (2) westbound left-turn from Linda Avenue to Kingston Avenue. However, the peak hour traffic volumes of these two movements are relatively small compared to other movements. For example, the AM southbound through movement on Kingston Avenue is 15 vehicles per hour, while AM southbound through movement on Rose Avenue is 79 vehicles per hour.
  - Given that the considerations for placing the stop signs as shown in Figure 1 for **Concept 1** are still present under **Concept 2**, and that the additional travel affects a relatively small number of vehicles, Figure 2 presents identical stop sign placement for **Concept 2**.
- Under **Concept 1** only, place “YIELD” signs (CA MUTCD R1-2) on the terminus of the one-way (southbound) Kingston Avenue approach. Vehicles traveling on the one-way link would then yield to other southbound vehicles on the two-way Kingston Avenue facility.

- Under **Concept 2** only, place a “DO NOT ENTER” sign (CA MUTCD R5-1) facing north on Kingston Avenue. This would deter motorists from traveling on the wrong way in the northbound-only Kingston Avenue link.

#### *Pavement Markings*

- Pavement marking changes are shown in Figure 1 and Figure 2 to facilitate stop sign compliance from drivers on eastbound Linda Avenue.
  - Install stop lines and yield lines to indicate the point behind which vehicles are required to stop and yield, respectively. Stop lines and yield lines can increase the driver’s view of pedestrians, provide increased sight distance for turning vehicles, and increase the turning radius for left-turning vehicles (CA MUTCD §3B.16, 2014). Please refer to the CA MUTCD Section 3B.16 for guidance on dimensions and placement of stop and yield lines.
  - Under **Concept 2**, install pavement markings south of the landscaped median to reinforce the one-way operation around the median. These markings may include channelizing lines with optional white chevrons and double solid yellow centerlines.
  - Install parking “T’s”, as shown in Figure 6, be striped onto the pavement to aid drivers and to help bicyclists identify and steer clear of the “door zone” of parked vehicles. This may help address bicyclist crashes involving parked cars. The historical crash data discussed above included three (3) crashes involving parked cars.

## Pedestrian and Bicycle

- According to the NACTO Urban Bikeway Design Guide<sup>3</sup>, “sharrow” markings on Linda Avenue—as recommended by the City of Piedmont Pedestrian and Bicycle Master Plan—should not be less than 112 inches by 40 inches (see CA MUTCD Figure 9C-9).
- Because Linda Avenue has on-street parallel parking, the CA MUTCD §9C.07 guidance states the “sharrow” should be placed so the center of the markings are at least 11 feet from the face of the curb.
- Also according to the CA MUTCD §9C.07, “sharrow” markings should be placed immediately after an intersection and spaced at intervals not greater than 250 feet thereafter.
- CA MUTCD §9B.06-compliant signs, such as “[Bicycles] MAY USE FULL LANE” (R4-11), can be placed on the roadside as recommended in the City of Piedmont Pedestrian and Bicycle Master Plan.
- Consider removing or repainting centerline stripes along the enhanced bike route, as drivers have an easier time passing bicyclists on roads that do not have centerline striping<sup>3</sup>. Centerline stripes near intersections are desirable to guide motorists.
- According to the California Vehicle Code Section 21368 (“Crosswalks Near Schools”), all marked pedestrian crosswalks at an intersection must be painted in yellow if any one of them is yellow. It allows yellow markings if the nearest point of the crosswalk is not more than 600 feet from a school building or grounds thereof.
- Consider marking crosswalks with high-visibility plastic or epoxy material embedded with reflective glass beads. Although more expensive, longer-lasting, high-visibility crosswalk marking materials are a better value over time as they require less maintenance<sup>4</sup>.
  - Restripe the west crosswalk across Linda Avenue as a ladder crosswalk because Linda Avenue is uncontrolled at that location.

## Transit Access

- The potential changes described above increase pedestrian access to the two bus stops at the study intersection. The existing red curb along the bus stops allows buses to pull out to the curb side to pick up or drop off passengers.

## OTHER POTENTIAL CHANGES FOR CONSIDERATION

The following potential changes are not part of the traffic control and pavement marking review performed as part of this project. They are included for consideration as they may provide increased level of service to users of the intersection.

### **Lighting**

Review and confirm the lighting at the Linda Avenue crosswalk illuminates the pedestrian crossing itself at appropriate light levels. If needed, consider modifying lighting to enhance visibility of pedestrians at night.

### **Traffic Volume Management**

If cut-through traffic is a concern on Rose Avenue, the southbound one-way link of Kingston Avenue could be closed just downstream of the crosswalk under **Concept 1**. (This could not work under **Concept 2** as there would be no southbound link on Kingston Avenue.)

The road segment could be converted to a two-way local access road for those residential driveways by removing three or four on-street parking spaces. This would reduce automobile-pedestrian conflicts and turning speeds for eastbound Linda Avenue traffic turning right on Kingston Avenue. Restriping and removal of parking spaces on the south leg of Kingston Avenue may be needed to accommodate turning traffic.



## CONCLUSION

KAI identified potential changes to pavement markings and traffic controls at the Kingston Avenue/Linda Avenue/Rose Avenue intersection based on the background information, the traffic data, and the Multiway Stop Control Warrant analysis presented above. Figure 1 and Figure 2 at the beginning of this document summarize the potential improvements identified by the KAI team for **Concept 1** and **Concept 2**, respectively.

The vehicular traffic volumes on Linda Avenue and the vehicular, pedestrian, and bicyclist volumes on the two minor streets (Kingston Avenue and Rose Avenue) meet the Criterion C of the all-way stop control warrant in the CA MUTCD. In addition, left-turn movements from northbound Kingston Avenue could benefit from traffic control on Linda Avenue, especially following the implementation of the landscaping plan.

One of the several potential improvements discussed in this report is to place “STOP” signs on the eastbound and westbound approaches of Linda Avenue at the intersection with the two-way Kingston Avenue, converting it to a four-way stop controlled intersection.

## APPENDIX B: MUTCD SECTION 2B.07

### **Section 2B.06 STOP Sign Applications**

#### *Guidance:*

- o At intersections where a full stop is not necessary at all times, consideration should first be given to using less restrictive measures such as YIELD signs (see Sections 2B.08 and 2B.09).
- o The use of STOP signs on the minor-street approaches should be considered if engineering judgment indicates that a stop is always required because of one or more of the following conditions:
  - A. The vehicular traffic volumes on the through street or highway exceed 6,000 vehicles per day;
  - B. A restricted view exists that requires road users to stop in order to adequately observe conflicting traffic on the through street or highway; and/or
  - C. Crash records indicate that three or more crashes that are susceptible to correction by the installation of a STOP sign have been reported within a 12-month period, or that five or more such crashes have been reported within a 2-year period. Such crashes include right-angle collisions involving road users on the minor-street approach failing to yield the right-of-way to traffic on the through street or highway.

#### *Support:*

- o The use of STOP signs at grade crossings is described in Sections 8B.04 and 8B.05.

### **Section 2B.07 Multi-Way Stop Applications**

#### *Support:*

- o Multi-way stop control can be useful as a safety measure at intersections if certain traffic conditions exist. Safety concerns associated with multi-way stops include pedestrians, bicyclists, and all road users expecting other road users to stop. Multi-way stop control is used where the volume of traffic on the intersecting roads is approximately equal.

- o The restrictions on the use of STOP signs described in Section 2B.04 also apply to multi-way stop applications.

#### *Guidance:*

- o The decision to install multi-way stop control should be based on an engineering study.
- o The following criteria should be considered in the engineering study for a multi-way STOP sign installation:
  - A. Where traffic control signals are justified, the multi-way stop is an interim measure that can be installed quickly to control traffic while arrangements are being made for the installation of the traffic control signal.
  - B. Five or more reported crashes in a 12-month period that are susceptible to correction by a multi-way stop installation. Such crashes include right-turn and left-turn collisions as well as right-angle collisions.
  - C. Minimum volumes:
    1. The vehicular volume entering the intersection from the major street approaches (total of both approaches) averages at least 300 vehicles per hour for any 8 hours of an average day; and
    2. The combined vehicular, pedestrian, and bicycle volume entering the intersection from the minor street approaches (total of both approaches) averages at least 200 units per hour for the same 8 hours, with an average delay to minor-street vehicular traffic of at least 30 seconds per vehicle during the highest hour; but
    3. If the 85<sup>th</sup>-percentile approach speed of the major-street traffic exceeds 40 mph, the minimum vehicular volume warrants are 70 percent of the values provided in Items 1 and 2.
  - D. Where no single criterion is satisfied, but where Criteria B, C.1, and C.2 are all satisfied to 80 percent of the minimum values. Criterion C.3 is excluded from this condition.


#### *Option:*

- o Other criteria that may be considered in an engineering study include:
  - A. The need to control left-turn conflicts;
  - B. The need to control vehicle/pedestrian conflicts near locations that generate high pedestrian volumes;
  - C. Locations where a road user, after stopping, cannot see conflicting traffic and is not able to negotiate the intersection unless conflicting cross traffic is also required to stop; and
  - D. An intersection of two residential neighborhood collector (through) streets of similar design and operating characteristics where multi-way stop control would improve traffic operational characteristics of the intersection.
